Beginning at a point 503.51 feet North 0°35'27" East and 956.45 feet South 89°24'33" East from the Southwest corner of the Northwest Quarter of the Southwest Quarter of Section 21, Township 3 North, Range 8 East of the Willamette Meridian as measured along the West line of the Southwest Quarter and at a right angle to said line; thence North 0°35'27" East parallel to the said West line of the Southwest Quarter 163.39 feet; thence South 89°24'33" East 388.87 feet more or less to the East line of the said Northwest Quarter of the Southwest Quarter of Section 21; thence South 0°50'17" West along the East line 359.22 feet more or less to the North line of the Gregorius Tract as recorded in Book X, Page 135; thence North 88°12'09" West along the North line of said Gregorius Tract 387.41 feet more or less to a point that bears South 0°35'27" West from the point of beginning; thence North 0°35'27" East 187.66 feet to the point of beginning;

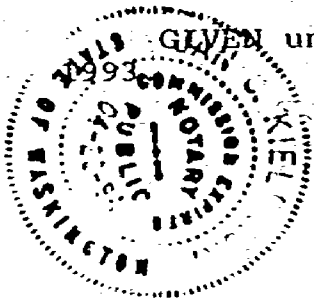
