A strip of land situate in the Southwest quarter of the Southwest quarter of Section 23, T3N, R8E, W.M., in the County of Skamania and the State of Washington, described more particularly as follows:

Beginning at a point 525 feet East of the southwest corner of said Section 23, which is an iron rod marking the southwest corner of the parcel described in that particular document recorded in Book 118 at Page 979 of Deeds, Skamania County Auditors No. 109265; thence at right angle to said line North, 235 feet along the west line of said parcel to an iron rod marking the northwest corner thereof; thence at right angle to said last line West, 10 feet; thence at right angle to said last line South, 235 feet to the south line of said Section 23; thence East on said line 10 feet to the Point of Beginning, containing 0.05 acres more or less.

This deed constitutes a boundary line adjustment between the adjoining property of the grantor and grantee herein, and is therefore exempt from the requirements of RCW 58.17 and the Skamania County Short Plat Ordinance. The herein described property cannot be segregated and sold without first conforming to the State of Washington and Skamania County Subdivision laws.

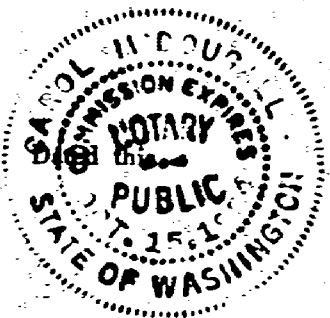
