EASEMENT SUPPLEMENT

THIS SUPPLEMENTAL AGREEMENT, made and entered into this 8th day of May, 1992, by and between EMMY G. BIRKENFELD, as trustee of the WILHELM BIRKENFELD TRUST, herein called "Birkenfeld," and STATE OF WASHINGTON, acting by and through the Department of Natural Resources, herein called "State," WITNESSETH:

On the 5th day of August, 1986, State, granted an easement referred to herein as the Original Easement, to Birkenfeld, said Original Easement being recorded in the records of Skamania County, Washington, on August 11, 1986, in Volume 102 of Deeds, pages 199-201 under Auditor's File No. 101643. Said Original Easement is hereby supplemented as follows:

State, for and in consideration of Twenty Thousand Five Hundred Seventy-Two and no/100 Dollars (\$20,572.00) hereby grants and conveys to Birkenfeld, its successors and assigns, a permanent easement upon, over, and along rights of way sixty (60) feet in width over and across parts of Government Lot 5, N $\frac{1}{2}$ SW $\frac{1}{4}$ NE $\frac{1}{4}$ , S2 Government Lots 2, 3 & 4, NW $\frac{1}{4}$ SW $\frac{1}{4}$ NW $\frac{1}{4}$ , Section 1; Government Lots 1 & 2, NE $\frac{1}{4}$ SE $\frac{1}{4}$ NE $\frac{1}{4}$ , Section 2, all in Township 3 North, Range 7 East, and Government Lot 10, Section 1, Township 3 North, Range 7 $\frac{1}{2}$  East, W.M., in Skamania County, Washington, being thirty (30) feet on each side of the centerline of a road located approximately as shown in red on the attached "Exhibit A."

Subject as to said lands to all matters of public record.

Thirty (30) days prior to any reconstruction, or development, Birkenfeld shall submit to the Regional Manager at Castle Rock, Washington, for written approval, a complete and detailed plan of operation for the development of the right of way. Birkenfeld operations specified hereinabove shall be conducted in accordance with the provisions of the State approved Plan of Operation in force at the time of the commencement of said operations and Birkenfeld shall provide for the examination of the right of way with the State's Regional Manager, before any reconstruction, or development is commenced.

Except as herein supplemented all of the terms, conditions and reservations of the Original Easement shall remain in full force and effect.

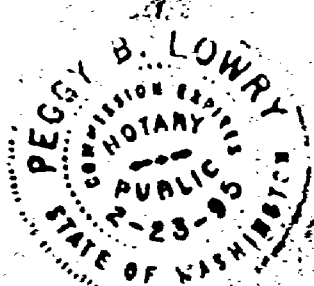

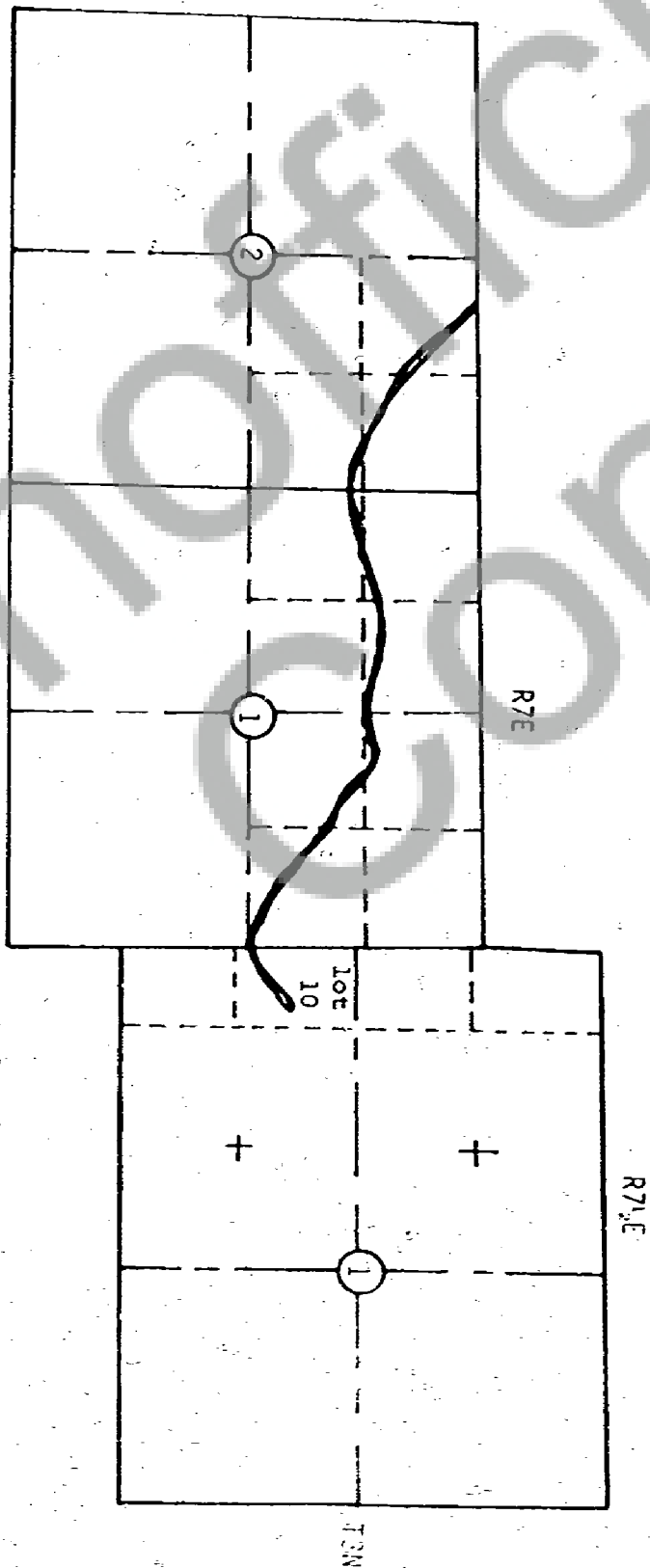
