
The following described real property located in Skamania County, State of Washington, to-wit:

BEGINNING at the intersection of the center of the channel of Rock Creek with the South line of Section 36, Township 3 North, Range 7 East of the Willamette Meridian; thence east to a point 4.39 chains West to the quarter corner on the South line of the said Section 36; thence North 05°30' West 662.5 feet, more or less, to the North boundary of the town of Stevenson; thence West to the center of the channel of Rock Creek; thence following the center of the channel of Rock Creek southerly to the point of beginning;

EXCEPT a tract of land conveyed to P.E. Michell by deed recorded at page 159 of Book "S" of deeds; records of Skamania County, Washington;

AND EXCEPT the following described tract: Beginning at the Southeast corner of the tract first above described; thence along the South line of the said Section 36 West 225 feet to the initial point of the tract hereby excepted; thence North 275 feet; thence West to the center of the channel of Rock Creek; thence following the center of the channel of Rock Creek southerly 275 feet, more or less, to the South line of the said Section 36, thence East to the initial point.

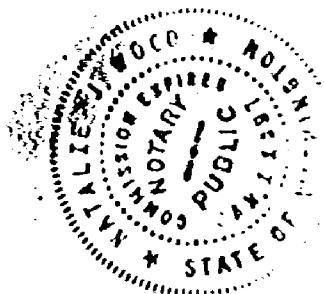


