EXHIBIT "A"

A Portion of the West Half of the Southwest Quarter of Section 5, Township 1 North, Range 5 East of the Willamette Meridian, Skamania County, Washington, described as follows:

Beginning at the Southwest Corner of said Southwest Quarter; thence North 00 degrees 48' 52" East along the West line of said Southwest Quarter, 834.82 feet; thence South 89 degrees 13' 08", East 660.00 feet to the true point of beginning; thence North 00 degrees 46' 52", East parallel with the West line of said Southwest Quarter 244.69 feet; thence South 89 degrees 13' 08", East 330 feet; thence South 00 degrees 46' 52" West parallel with the West line of said Southwest Quarter 612.83 feet to the North right of way line of the Belle Center County Road; thence, following said right of way line, along the arc of a 348.3 feet radius curve to the left (the incoming tangent of which is North 89 degrees 45' 52" West) for an arc distance of 138.74 feet; thence South 82 degrees 39' 13", West 59.19 feet; thence South 50 degrees 28' 16", West 101.12 feet; thence South 59 degrees 00' 07", West 69.95 feet; thence leaving said right of way line, North 00 degrees 46' 52" East parallel with the West line of said Southwest Quarter 507.22 feet to the true point of beginning.
