COLLINS as Trustee of the Jack D. Collins and Irma B. Collins Living Trust, executed the 18 day of August, 1993, hereinafter called Grantee, and unto Grantee's heirs, successors and assigns all of the Grantor's right, title and interest in that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, situated in Skamania County, State of Washington, described as follows, to-wit:

Lot 1 of JACK D. COLLINS SHORT PLAT NO. 5, according to plat recorded in Book 2 at Page 192 of Short Plats, Skamania County, Washington, more particularly described as:

That part of the East 1/2 of the East 1/2 of the Southeast 1/4 of the Northwest 1/4 of Sec. 9, Township 1 N. Range 5 E. W.M. lying south of Mt. Pleasant Rd.

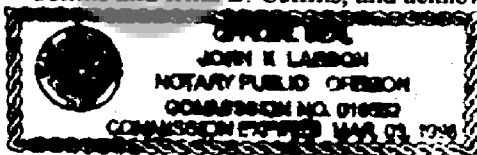
