PARCEL 1

A tract of land in the West half of the Southeast quarter of the Northwest quarter of Section 36, Township 3 North, Range 7 East of the Willamette Meridian in the County of Skamania and State of Washington, described as follows:

Beginning at a point on the Northerly line of the county road known and designated as Gropper Road, said point being 320 feet Easterly of the center line running North and South through the center of the Northwest quarter of the said Section 36; thence Easterly along the Northerly line of said county road 16 feet, more or less, to a point 336 feet Easterly of the center line aforesaid; thence North 01 degrees 37' West 208 feet; thence West to a point North of the point of beginning; thence South 208 feet, more or less, to the point of beginning.

PARCEL 2

A tract of land in the West half of the Southeast quarter of the Northwest quarter of Section 36, Township 3 North, Range 7 East of the Willamette Meridian, in the County of Skamania, State of Washington, described as follows:

Beginning at the intersection of Gropper Road aforesaid with the center line running North and South through the Northwest quarter of the said Section 36; thence following said center line North 281.8 feet; thence East 205 feet to the initial point of the tract hereby described; thence East 115 feet; thence South 279 feet, more or less, to the center line of said Gropper Road; a Westerly direction along the center line of said road to a point South of the initial point; thence North to the initial point.
