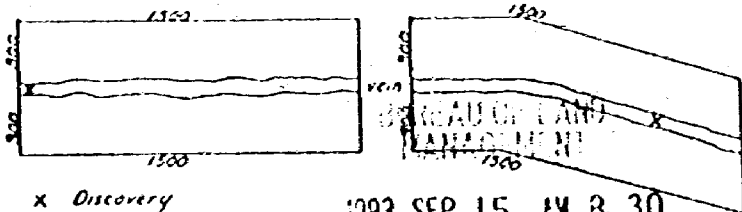

NOTICE IS HEREBY GIVEN That the undersigned who<sup>(s)</sup>are (ha\_\_\_ declared \_\_\_ intention to become) citizen\_\_\_ of the United States, has\_\_\_ discovered and has\_\_\_ located and claimed and does hereby locate 1500 linear feet in length, and 600 feet in width on the QUARTZ VEIN

\_\_\_\_\_. Lode, vein, ledge or deposit (or placer ground), situated in the above State, County (or Recording Precinct) and Mining District, and further described as follows: Commencing at a post marked No. 1 at the Discovery shaft (cut or tunnel), from thence 1500 feet in a NORTH direction to an end post marked No. 2, thence 300 feet in a EAST direction to a corner post marked No. 3, thence 1500 feet in a SOUTH direction to a corner post marked No. 4, thence 600 feet in a WEST direction to a corner post marked No. 5, thence 1500 feet in a NORTH direction to a corner post marked No. 6, thence 300 feet in a EAST direction to said end post No. 2; hereby locating and intending to claim 1500 feet in a NORTH direction from discovery to the CENTER end line, and \_\_\_\_\_ feet in the opposite direction from discovery to the \_\_\_\_\_ end
