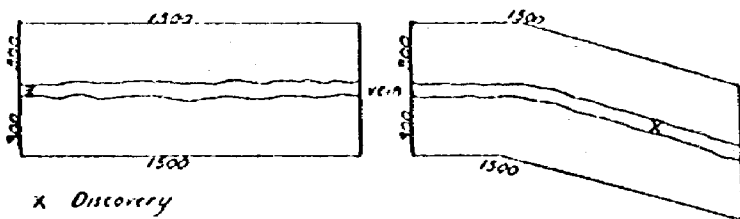


NOTICE OF MINING LOCATION

NOTICE IS HEREBY GIVEN That the undersigned who is/are (ha___ declared ___ intention to become) citizen___ of the United States, has discovered and has located and claimed and does hereby locate 1500 linear feet in length, and 600 feet in width on the Wind River #19. Lode, vein, ledge or deposit (or placer ground), situated in the above State, County (or Recording Precinct) and Mining District, and further described as follows: Commencing at a post marked No. 1 at the Discovery shaft (cut or tunnel), from thence 600 feet in a E-NE direction to an end post marked No. 2, thence 1500 feet in a N-NW direction to a corner post marked No. 3, thence 600 feet in a W-SW direction to a corner post marked No. 4, thence 1500 feet in a S-SE direction to a corner post marked No. 5, thence TO THE POINT OF BEGINNING feet in a ___ direction to a corner post marked No. 6, thence ___ feet in a ___ direction to said end post No. 2; hereby locating and intending to claim ___ feet in a ___ direction from discovery to the ___ end line, and ___ feet in the opposite direction from discovery to the ___ end line and ___ feet on each side of the middle of said lode or ledge, for the purpose of mining the same and claiming all surface rights, privileges, and minerals, with all dips, spurs, angles and variations, and other rights granted by existing laws and customs.
