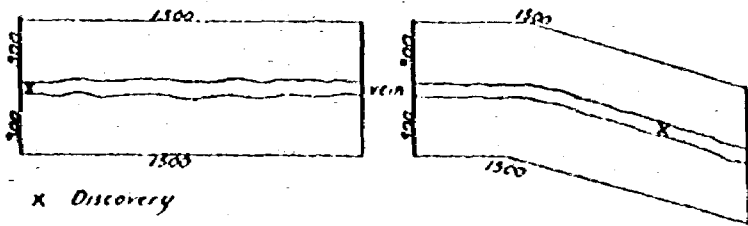


# NOTICE OF MINING LOCATION

NOTICE IS HEREBY GIVEN That the undersigned who is/are (has declared \_\_\_\_\_ intention to become) citizen \_\_\_\_\_ of the United States, has discovered and has located and claimed and does hereby locate 1500 linear feet in length, and 600 feet in width on the \_\_\_\_\_
