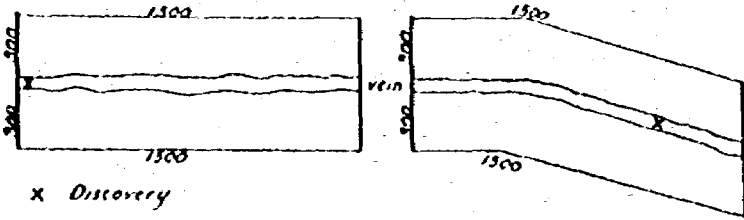


NOTICE OF MINING LOCATION

NOTICE IS HEREBY GIVEN That the undersigned who is/are (has/declared intention to become) citizen of the United States, has discovered and has located and claimed and does hereby locate 1500 linear feet in length, and 600 feet in width on the

R.G.B. # 13

Lode, vein, ledge or deposit (or placer ground), situated in the above State, County (or Recording Precinct) and Mining District, and further described as follows: Commencing at a post marked No. 1 at the Discovery shaft (cut or tunnel), from thence 1500 feet in a southwesterly direction to an end post marked No. 2, thence 600 feet in a southeasterly direction to a corner post marked No. 3, thence 1500 feet in a northeasterly direction to a corner post marked No. 4, thence 600 feet in a northwesterly direction to a corner post marked No. 5, thence feet in a direction to a corner post marked No. 6, thence feet in a direction to said end post No. 2; hereby locating and intending to claim feet in a direction from discovery to the end line, and feet in the opposite direction from discovery to the end line and feet on each side of the middle of said lode or ledge, for the purpose of mining the same and claiming all surface rights, privileges, and minerals, with all dips, spurs, angles and variations, and other rights granted by existing laws and customs.
