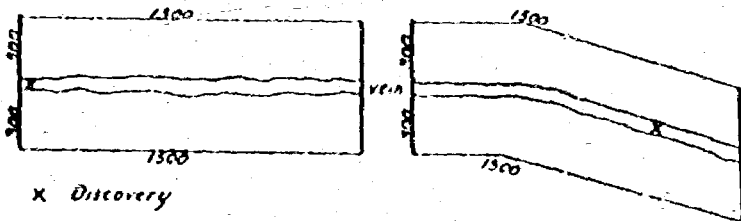


NOTICE OF MINING LOCATION
