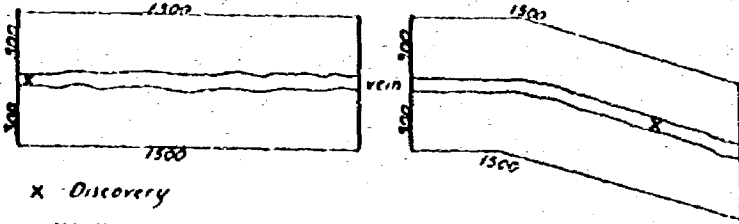


NOTICE OF MINING LOCATION

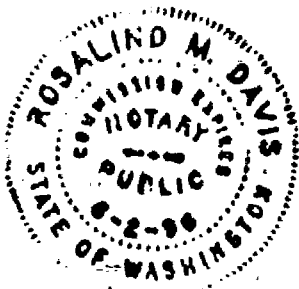
