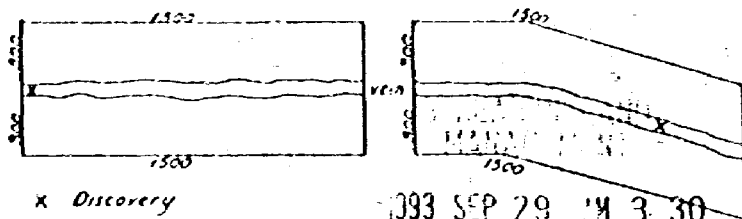

NOTICE IS HEREBY GIVEN That the undersigned who (is) are (ha___ declared ___ intention to become) citizen___ of the United States, ha___ discovered and ha___ located and claimed and do___ hereby locate 1500 linear feet in length, and 600 feet in width on the QUARTZ VEIN

___ Lode, vein, ledge or deposit (or placer ground), situated in the above State, County (or Recording Precinct) and Mining District, and further described as follows: Commencing at a post marked No. 1 at the Discovery shaft (cut or tunnel), from thence 600 feet in a SOUTH direction to an end post marked No. 2; thence 1500 feet in a WEST direction to a corner post marked No. 3, thence 600 feet in a NORTH direction to a corner post marked No. 4, thence 1500 feet in a EAST direction to a corner post marked No. 5, thence ___ feet in a POINT OF BEGINNING direction to a corner post marked No. 6, thence ___ feet in a ___ direction to said end post No. 2; hereby locating and intending to claim ___ feet in a ___ direction from discovery to the ___ end line, and ___ feet in the opposite direction from discovery to the ___ end line and ___ feet on each side of the middle of said lode or ledge, for the purpose of mining the same and claiming all surface rights, privileges, and minerals, with all dips, spurs, angles and variations, and other rights granted by existing laws and customs.
