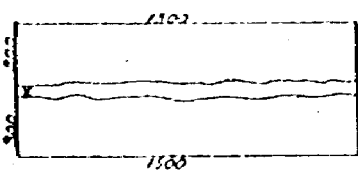

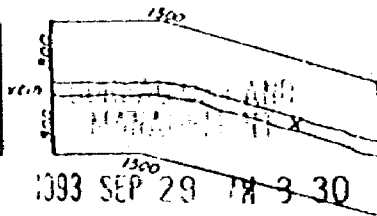
NOTICE OF MINING LOCATION

NOTICE IS HEREBY GIVEN That the undersigned who is are (ha___ declared ___ intention to become) citizen___ of the United States, ha___ discovered and ha___ located and claimed and do___ hereby locate 1500 linear feet in length, and 600 feet in width on the QUARTZ VEIN

_____. Lode, vein, ledge or deposit (or placer ground), situated in the above State, County (or Recording Precinct) and Mining District, and further described as follows: Commencing at a post marked No. 1 at the Discovery shaft (cut or tunnel), from thence 1500 feet in a EAST direction to an end post marked No. 2, thence 600 feet in a SOUTH direction to a corner post marked No. 3, thence 1500 feet in a WEST direction to a corner post marked No. 4, thence 600 feet in a NORTH direction to a corner post marked No. 5, thence 1500 feet in a POINT OF BEGINNING direction to a corner post marked No. 6, thence 600 feet in a POINT OF BEGINNING direction to said end post No. 2; hereby locating and intending to claim 1500 feet in a POINT OF BEGINNING direction from discovery to the POINT OF BEGINNING end line, and 600 feet in the opposite direction from discovery to the POINT OF BEGINNING end line and 600 feet on each side of the middle of said lode or ledge, for the purpose of mining the same and claiming all surface rights, privileges, and minerals, with all dips, spurs, angles and variations, and other rights granted by existing laws and customs.

This claim is further described by reference to natural objects or permanent monuments, as follows:
DISCOVERY LOCATED 1600' N.W. FROM THE N.E. CORNER OF SEC. 4, T-5N., R. 7E., WIND RIVER QUAD., WASH. THE DISCOVERY IS FURTHER LOCATED 5300' N.W. OF LAVA BUTTE. THE DISCOVERY IS A COMMON CORNER WITH BOHN #4, 5, 6, 8 - WILLAMETTE MERIDIAN.

This notice is placed at Discovery on post No. 1; posts are placed at each corner, and the name of this lode, and date of location, are placed on all posts.
