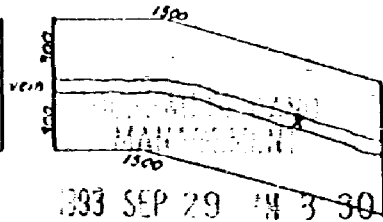
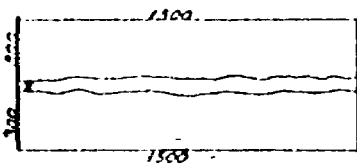

NOTICE IS HEREBY GIVEN That the undersigned who I are (ha\_\_\_ declared \_\_\_ intention to become) citizen\_\_\_ of the United States, ha\_\_\_ discovered and ha\_\_\_ located and claimed and do\_\_\_ hereby locate 1500 linear feet in length, and 600 feet in width on the QUARTZ VEIN

\_\_\_ Lode, vein, ledge or deposit (or placer ground), situated in the above State, County (or Recording Precinct) and Mining District, and further described as follows: Commencing at a post marked No. 1 at the Discovery shaft (cut or tunnel), from thence 600 feet in a NORTH direction to an end post marked No. 2, thence 1500 feet in a EAST direction to a corner post marked No. 3, thence 600 feet in a SOUTH direction to a corner post marked No. 4, thence 1500 feet in a WEST direction to a corner post marked No. 5, thence 600 feet in a POINT OF BEGINNING direction to a corner post marked No. 6, thence 600 feet in a POINT OF BEGINNING direction to said end post No. 2; hereby locating and intending to claim 600 feet in a POINT OF BEGINNING direction from discovery to the POINT OF BEGINNING end line, and 600 feet in the opposite direction from discovery to the POINT OF BEGINNING end line and 600 feet on each side of the middle of said lode or ledge, for the purpose of mining the same and claiming all surface rights, privileges, and minerals, with all dips, spurs, angles and variations, and other rights granted by existing laws and customs.
