BEGINNING at an iron stake on the Northerly line of State Highway No. 8 as the same existed on October 1, 1943, at a point 10 chains East of the West line of the Robbins D.L.C. in Section 27, Township 3 North, Range 8 East of the Willamette Meridian, in the County of Skamania, State of Washington; thence North 347 feet; thence North 72 degrees 15' West 178.2 feet to the Easterly line of the right of way of the Home Valley Road at an iron stake; thence South 75 degrees 14' West along the Easterly line of the said right of way of said Home Valley Road a distance of 274.6 feet to an iron stake; thence South 09 degrees West 128.8 feet to the Northerly line of said Highway No. 8 as aforesaid at an iron stake; thence South 66 degrees 31' East along the Northerly line of said State Highway No. 8 a distance of 491 feet to the Place of Beginning.

EXCEPT that portion thereof conveyed to the State of Washington for highway purposes by deed dated February 8, 1955, records at Page 257 of Book 39 of Deeds, records of Skamania County, Washington.

And that portion beginning at an iron stake on the Northerly line of State Highway No. 8 as the same existed on October 1, 1943, at a point 10 chains East of the West line of the Robbins D.L.C. in Section 27, Township 3 North, Range 8 East of the Willamette Meridian, in the County of Skamania, State of Washington; thence North 332.3 feet to the initial point of the tract hereby described said point being the Southeast corner of the second parcel of a tract of land conveyed to the grantors by deed dated April 3, 1961, and recorded at Page 245 of Book 54 of Deeds, records of Skamania County, Washington; thence West 388.58 feet, more or less, to intersection with the Easterly right of way line of the Berge Road; thence in a Northeasterly direction along said right of way line 315 feet, more or less, to the Southerly right of way line of the Wedrick Road; thence Southeasterly along the Southerly right of way line of the Wedrick Road 90 feet, more or less, to a point North of the initial point; thence South 90 feet, more or less, to the initial point.
