NOTICE IS HEREBY GIVEN, that the undersigned, having complied with the requirements of chapter six, Title thirty-two of the revised statutes of the united states, and the laws of the above state, and the local customs and regulations of said district, has located and does hereby locate 1500 linear feet in length, and 600 feet in width on the BLUE DOT #1 lode, vein, ledge situated in above state, county or mining district, and further described as follows: commencing at a post marked no#1 at the discovery shaft (cut or tunnel) from thence 300 feet in a WESTERLY direction to an end post marked no#2, thence 1500 feet in a NORTHERLY direction to a corner post marked no#3, thence 300 feet in a EASTERLY direction to a corner post marked no#4 thence 300 feet in a EASTERLY direction to a corner post marked no#5 thence 1500 feet in a SOUTHERLY direction to corner post marked no#6 thence 600 feet in a WESTERLY direction to said end post no#2: hereby locating and intending to claim 1400 feet in a NORTH direction from discovery to the NORTH end line, and 100 feet in the opposite direction from discovery to the SOUTH end line, and 300 feet on each side of the middle of said lode or ledge, for the purpose of mining the same and claiming all surface rights, privileges minerals, with all dips, spurs, angles and variations, and other rights granted by existing laws and customs. 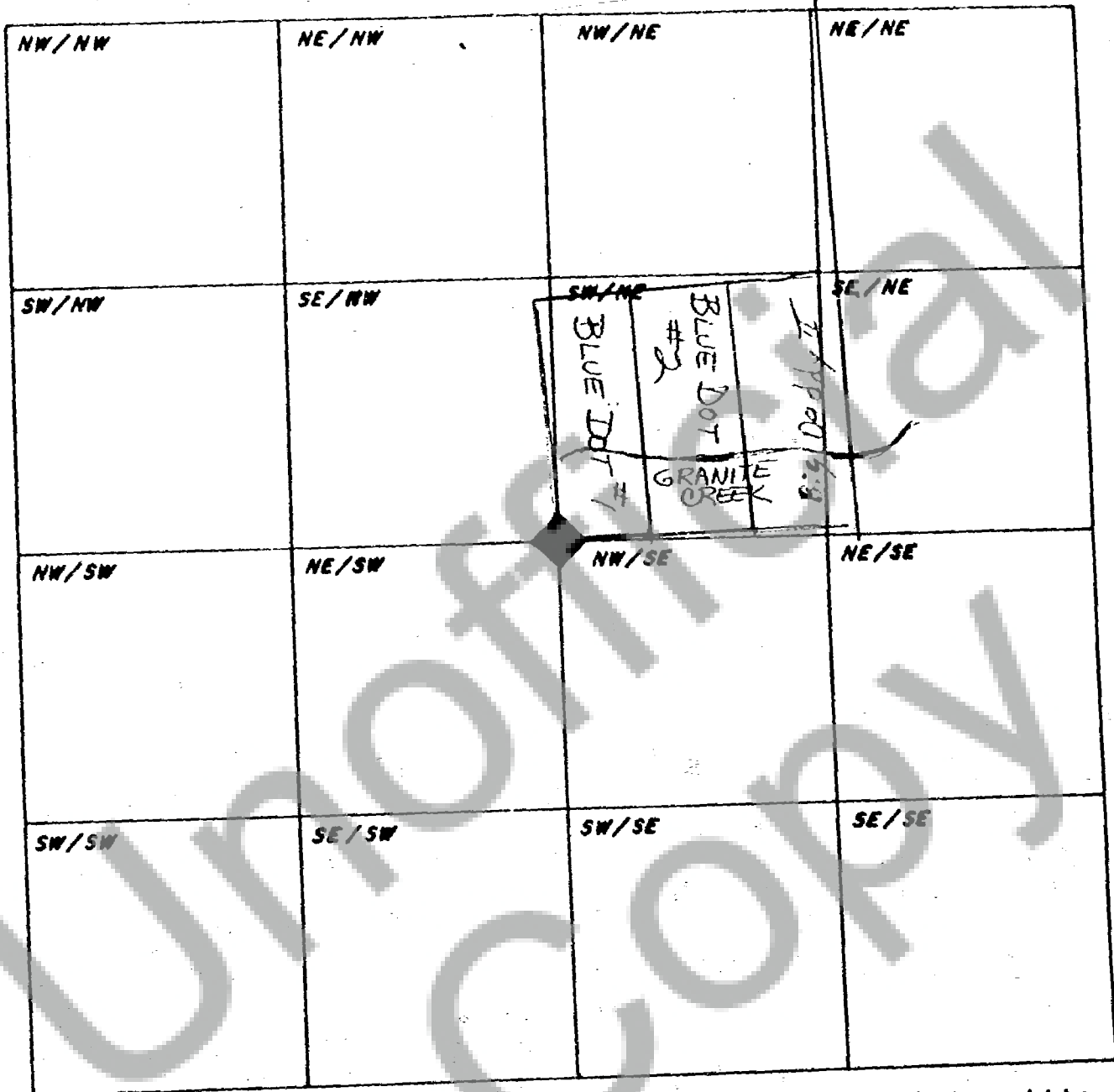
