Notice of location must be recorded within thirty (30) days from the date of discovery at the office of the auditor of the county in which such discovery was made. Twenty (20) Acres may be included in one placer claim and if located on surveyed land it must be according to legal subdivisions.

Care must be taken to fully describe the claim with reference to natural objects and permanent monuments or survey description, so that the boundaries can be readily traced. The blank spaces in this form must be carefully and properly filled out.
