DECREE GRANTING ABSOLUTE DIVORCE

The above-entitled action came on for hearing on
SEP 16 1993, 1993 before the Family Court of the First
Circuit, State of Hawaii, Honorable VICTORIA S. MARKS.

Following the hearing and after full consideration of all
of the evidence, the Court found the material allegations of the
First Amended Complaint for Divorce to be true, the Plaintiff to be
entitled to a divorce from the bonds of matrimony on the grounds
that the marriage is irretrievable broken, and this Court to have
jurisdiction to enter this decree. Now, therefore,

IT IS HEREBY ORDERED, ADJUDGED AND DECREED that:

1. A decree of absolute divorce is hereby granted to

are hereby dissolved and the parties are restored to the status of

3. Other matters covered by this decree are as follows:

a. Alimony: Neither party shall be required to pay alimony to the other party and the question of alimony is not reserved.

b. Former Name: Plaintiff may resume the use of her birth surname and be known hereafter as LYNETTE KATHRYN LEZCANO.

c. Agreement Incident to and in Contemplation of Divorce: The Agreement Incident to and in Contemplation of Divorce entered into by and between the parties on June 25, 1992 is approved by the Court and incorporated herein by reference.

d. Real Property: Plaintiff is awarded the marital residence located at 1121 Aukele Street, Kailua, Hawaii 96734, TMK 4-2-21-20, free and clear of any claims of Defendant. Defendant is awarded the marital residence located at M.P. 081 Carson Depot Road, Washington 98610, TMK 3-8-29-1-1-5301, free and clear of any claims of Plaintiff.

e. Personal Property (includes accounts, cars, furnishings, etc.): Each party is awarded all property presently in his or her title or possession.

f. Retirement: Each party is awarded his or her own retirement benefits.

g. Debts: Each party shall assume and pay his or her own debts and shall indemnify and hold harmless the other party
