THE POINT IS A 2-1/2 INCH DIAMETER BRASS DISK STAMPED "CLARK COUNTY CONTROL POINT 18900 1992" SET INTO BEDROCK ON A FLAT EXPOSED AREA ON SILVER STAR MOUNTAIN ABOUT 600 FEET SOUTHWESTERLY OF THE NORTHERLY TRAILHEAD AT THE END OF US FOREST SERVICE ROAD 4109.

THE STATION IS ABOUT 14 MILES EAST OF BATTLEGROUND IN SECTION 7 T3N R5E. TO REACH THE STATION FROM THE INTERSECTION OF YACOLT ROAD AND RAILROAD AVE IN THE TOWN OF YACOLT:

- * GO SOUTHEAST ON RAILROAD AVE 2.6 MILES TO SUNSET FALLS ROAD (COUNTY ROAD NO. 12),
- * LEFT (EAST) ON SUNSET FALLS ROAD 1.9 MILES TO DOLE VALLEY ROAD,
- * RIGHT (SOUTH AND EAST) ON DOLE VALLEY ROAD 2.5 MILES TO THE L-1100 ROAD,
- * LEFT (EAST) ON L-1100 2.0 MILES TO TARBELL CAMPGROUND (ROAD L-1210) CONTINUE EAST ON L-1100 2.1 MILES TO FORK IN THE ROAD, TAKE LEFT FORK 2.1 MILES TO US FOREST SERVICE ROAD 4109,
- * RIGHT (SOUTH) ON 4109 3.5 MILES TO TRAILHEAD PARKING AREA AT END OF ROAD,
- * WALK WEST AND SOUTH ON ABANDONED ROAD (SILVER STAR TRAIL) UPHILL ABOUT 600 FEET, LEAVE TRAIL RIGHT (WEST) AND WALK TO FLAT ROCKY AREA AND STATION POINT. THE STATION IS APPROXIMATELY 31 FEET EAST OF SMALL ROCK BLUFFS AND 550 FEET SOUTH OF A BARE GRASSY HUMP.

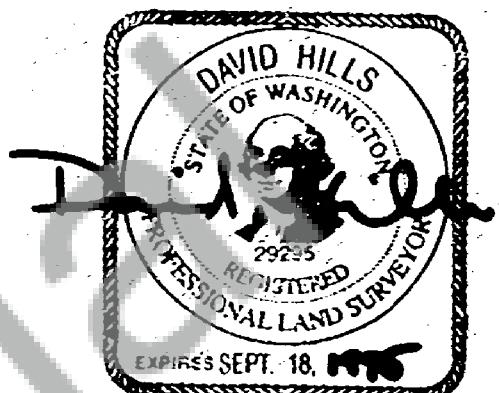

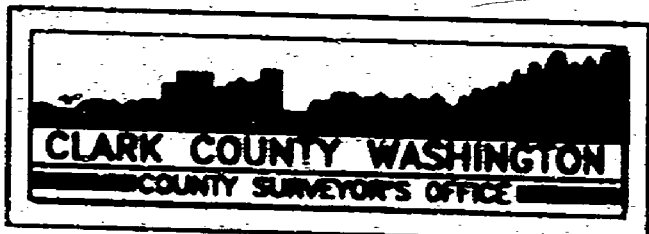
