THE UNDERSIGNED INDIVIDUAL, ACTING AS principal, domiciled and residing in the State of Washington, as authorized by HCW 11.94.010, acting separately and individually, designates the following named person as attorney in fact to act for me.

- 1. Designation: SANDRA R. HEIRMAN is designated as attorney in fact for the principal, both immediately and upon her becoming disabled and/or incompetent.
- 2. Powers. The attorney in fact, as fiduciary, shall have all powers of an absolute owner over the assets and liabilities of the principal, whether located within or without the State of Washington. In particular the attorney in fact shall have the power to transfer assets of the principal for the purpose of qualifying the principal for public medical assistance or care under State or Federal programs to assist the medically needy. The attorney in fact shall not have the power to revoke or change any estate planning or testamentary documents previously executed by principal, unless the document authorizes changes with court approval.
- 3. Purposes. The attorney in fact shall have all powers as are necessary or desirable to provide for the support, maintenance, health, emergencies and urgent necessities of the principal.
- 4.5 Effectiveness. This power of attorney shall become effective immediately upon the execution of this document.
- 5. Duration. The durable power of attorney becomes effective as provided in Paragraph 4 and shall remain in effect until revoked or terminated under Paragraph 6 or 7, notwithstanding any uncertainty as to whether the principal is dead or alive.
- 8. Revocation. This power of attorney may be revoked, suspended or terminated in writing by me with written notice to the designated attorney in fact, and by recording the written instrument of revocation in the office of the auditor of Skamania County, Washington.

71: Termination.

- (a) By Appointment of Guardian. The appointment of a guardian of the estate of the principal vests in the guardian, with court approval, the power to revoke, suspend or terminate this power of attorney.
- (b) By Death of Principal. The death of the principal shall be deemed to revoke the power of attorney upon actual knowledge or actual notice being received by the attorney in fact.
- 8. Accounting. The attorney in fact shall be required to account to any subsequently appointed personal representative.
- 9. Reliance. The designated and acting attorney in fact and all persons dealing with the attorney in fact shall be entitled to rely upon this power of attorney so long as neither the attorney in fact nor any person with whom he was dealing at the time of any act taken pursuant to this power of attorney, had received actual knowledge or actual notice of any revocation, suspension or termination of the power of attorney be death or otherwise. Any action so taken, unless otherwise invalid or

unenforceable, shall be binding on the heirs, devisees, legatees or personal representatives of the principal.
