

Caldwell, of Clark County, Washington, being over the age of eighteen years, and of sound and disposing mind and memory, and not acting under duress, menace, fraud or undue influence, do make, publish and declare the following as my Last Will and Testament, hereby revoking all former Wills by me made.

FIRST:

I direct my executrix, hereinafter named,
to pay all my just debts which I may owe at the time of my death, including my
funeral expenses and the expenses of my last illness.

SECOND:

I give, devise and bequeath all of my
interest in Caldwell Acceptance Corporation presently doing business at 911 S.E.
Stark Street, Portland, Oregon, which interest is presently a one-nineth interest
which I inherited from my brother and consequently, is my separate property, to
my two daughters, Vivian E. Abbott and Claire L. Daily, share and share alike.

THIRD: All of the rest, residue, and remainder of my property which was acquired during my marriage which constitutes community I give, devise and bequeath unto my wife, Agnes N. Caldwell to her own use forever. In the event, however, my wife dies before I do, or in the event we die simultaneously, then I give, devise and bequeath all of the property which I may own at the time unto my two said daughters equally.
