Real property described as follows and located in the County of Skamania, State of Washington:

PARCEL I

The Southeast Quarter of the Northeast Quarter, and the North Half of the Northeast Quarter of the Southeast Quarter, of Section 29, Township 2 North, Range 5 East of the Willamette Meridian.

EXCEPT that portion thereof located westerly of County Road No. 1109 designated as the North Fork Road.

SUBJECT TO easements and restrictions of record.

ALSO EXCEPT:

Lot 1: A lot of two acres located as follows: Beginning at the Northeast corner of said Southeast Quarter of said Northeast Quarter; thence South along the section line 528 feet more or less; thence West 472 feet more or less to the true point of beginning; thence West 330 feet; thence South 264 feet; thence East 330 feet; thence North 264 feet to the true point of beginning. Together with a thirty foot easement through the sellers property located from the Southwest corner of the above lot in a southwesterly direction over an existing unimproved access road to the North Fork Road. Together with a ten foot easement through the sellers property located from the Northeast corner of the above lot in a Northeasterly direction along the existing waterline to the point where it leaves the sellers property.

That part of the Southeast one quarter of the Northeast one quarter that lies North of the Labarre Road and that part of the Southwest one quarter of the Northeast one quarter which lies South of the Burns Road (also known as the North Fork Road) and North of the Labarre Road, less 8.0 acres, described in that certain deed, #32914, from Lester and Blanche Burns to Henry G. Haussman dated September 23, 1943, and recorded under Auditor's Book 29, Page 583, records of Skamania County.
