EXHIBIT "A"

A Tract of land in the Northwest Quarter of the Northeast Quarter of Section 33, Township 2 North, Range 5 East of the Willamette Meridian, in the County of Skamania, State of Washington, described as follows:

Beginning at the Northeast Corner of the North Quarter of the Northeast Quarter of the said Section 33; thence West along the North line of said subdivision 462 feet; thence South to intersection with the centerline of the county road known and designated as the Washougal River Road, said point being the initial point of the tract hereby described; thence North 500 feet, more or less, to intersection with the South line of the Tract first above described; thence West 200 feet; thence South 500 feet, more or less, to intersection with the centerline of the Washougal River road aforesaid; thence following the centerline of said Road in an Easterly direction 200 feet, more or less, to the initial point.
