12 amount of \$550.00.

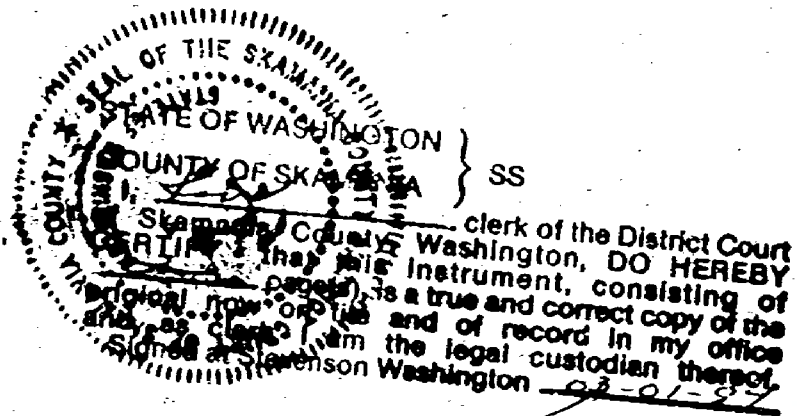
13 3. This judgment (pursuant to RCW 4.56.110) shall
