Recitals.

- 3. Property acquired after November 3, 1984, with rents, issues, income of, proceeds from, in exchange for or traceable to separate properties shall continue to be separate properties unless placed in the joint names of the parties as described in paragraph 2.
- 4. The property characterized as community property and any property acquired with rents, issues, income of, proceeds from, in exchange for or traceable to such community property shall retain its community property character unless placed in the separate name of a party.
- 5. It is not intended by this agreement to make any transfers of property between the parties, nor shall this agreement be construed for any purpose to effect any such
