2. At the time of her death, EDITH M. GLUR was a widow. Her husband, RUDOLPH GLUR, JR., died in Carson, Washington, on June 30, 1959.

3. The sole surviving heirs at law and beneficiaries of the last will and testament of EDITH M. GLUR are GENEVA GLUR KILANDER and JOHN R. GLUR. The deceased, EDITH M. GLUR, left no children or children of children who predeceased her other than those named in this affidavit.

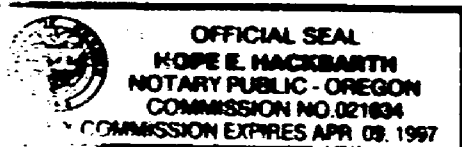
