A Tract of land located in Government Lot 8 of Section 36, Township 3 North, Range 8 East of the Willamette Meridian, Skamania County, Washington, described as follows:

Beginning at the intersection of the North line of said Government Lot 8 with the Northeasterly right of way line of County Road No. 3243 designated as the Girl Scout Road; thence South 48 degrees 13' East along the Northeasterly right of way line of said Road 467.9 feet; thence North 35 degrees 28' East 103 feet; thence North 06 degrees 26' East 138 feet; thence North 38 degrees 06' East 92.5 feet; thence North 18 feet, more or less, to the North line of said Government Lot 8; thence West along said North line 366.7 feet, more or less, to the Poinc of Beginning.
