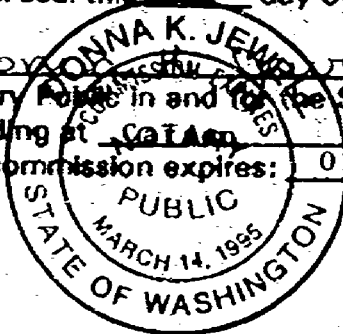

## EXHIBIT "A"

A Tract of land in the South Half of the South Half of Section 1, Township 1 North, Range 5 East of the Willamette Meridian, in the County of Skamania, State of Washington, described as follows:
