If If do not make any of the payments that I promised to make or do any of the things that I have agreed to do, you may do them. It will be up to me to see that the Reconveyance Deed is recorded and to pay any recording costs.
- 10. Balloon Payment. If this Dead of Trust secures a Note that provides for a balloon payment, the balloon payment will be financed by you at an interest rate that my be changed at your option to a rate not to exceed the then current rate offered by you for this type of loan and upon such other terms as you specify on like loans to other borrowers, provided that (a) you find no deterioration in my creditworthiness or the condition of the Property, and (b) your lien priority remains the same as at the time the loan was made.
- 11. Change of Address. If I move, I wilt immediately notify you in writing as to my new address. Any notice that I may give you or you may give me shall be given by regular mail at the addresses listed above or at such other address as I may designate by written notice to you.
 - 12. Governing Law. This Deed of Trust and the debt it secures will be governed by the taws of the state in which the Property is located
- 13. Definitions. The word "I" means all persons signing this Deed of Trust, and obligates each of us jointly and severally. "You" means Key Bank of Oregon or any holder of this Deed of Trust.
