AMENDMENT OF THE

SCIACCA SHORT PLAT NO. 2

The attached short plat map and legal descriptions describe a revised road easement and amendment of the <u>Sciacca Short Plat No. 2</u>, recorded April 4, 1991 at Book T of Short Plats, Page 31, Records of Skamania County, WA. The amendment revises only the access road easement over Lot 1 to Lot 2 of the short plat, reducing the easement width from a constant 20-foot width along the easterly line of Lot 1 to a tapered width, beginning with a 20-foot width at the northeasterly corner of Lot 1 and tapering to a 15-foot width at the southwesterly corner of Lot 1. After review of the proposal and after inspection of the onsite improvements made to the easement to maintain adequate road access to Lot 2, the City of Stevenson hereby approves the amendment subject to the consent of the property owners and recording of this amendment with the Skamania County Auditor.


