Contract of Sale Between County of Skamania and Salishan Lodge, Inc. For Golf Course and Meeting Facility of Skamania Lodge dated June 30, 1994

By the Contract of Sale, incorporated by reference herein as if set forth in full, County sells to Purchaser the Property described in the attached exhibit A, known as the Golf Course, including without limitation the County's interest if any, in any building or improvements thereon and appurtenances thereto, and County also sells to Purchaser the building improvement commonly known as the Conference Center or Meeting Center of Skamania Lodge located on land already owned in fee by Purchaser, including all appurtenances thereto. The purchase price is \$7,690,281.39.

The Contract of Sale provides for the payment of the purchase price in installments of principal, with the total remaining principal balance and accrued, unpaid interest due in full on June 30, 2005. The purchase price is adjusted in certain circumstances related to the County's receipt of U. S. Forest Service Grants, as more fully set forth in the Contract of Sale.

The Contract of Sale incorporates various covenants and terms, including without limitation, provisions for financing by Purchaser and for protection of the Purchaser's lender. The Contract of Sale gives to Purchaser an irrevocable license in perpetuity to use the Meadow, as described in the Contract.




