ASSIGNMENT OF TRUST DEED BY BENEFICIARY


Lot 3, Ridgeview Tracts, as recorded in Book A of Plats, page 150, in the County of Skamania and State of Washington.

Kment Trust, executed the 28 day of June, 1994, and an undivided one-half (1/2) interest as a tenant in common to PHYLLIS J. KMENT and KARL G. KMENT as Trustee of the Phyllis J. Kment Trust, executed the 28 day of June, 1994, hereinafter called Assignee, and Assignee's heirs, personal representatives, successors and assigns, all of the beneficial interest in and under said Trust Deed, together with the notes, moneys and obligations therein described or referred to, with the interest thereon, and all rights and benefits whatsoever accrued or to accrue under said Trust Deed.

KARL G. KMENT and PHYLLIS J. KMENT hereby covenants to and with said Assignee that KARL G. KMENT and PHYLLIS J. KMENT is the Beneficiary or Beneficiary's successor in interest under said Trust Deed and is the owner and holder of the beneficial interest therein and has the right to sell and assign the same and the note and obligation secured thereby.

In construing this instrument and whenever the context so requires, the singular includes the plural.




