





I, VERNA M. CHRISTAL, of Portland, Oregon, do make, publish and declare this to be my Last Will and Testament, and do revoke all other Wills and Codicils heretofore made by me.

ARTICLE I

I direct the payment out of my estate of all my just debts allowed in the course of administration, the expenses of my last illness and funeral and final interment, and the expenses of administration of my estate.

ARTICLE II
