## EXHIBIT "A"

A tract of land in the Southeast quarter of the Southwest quarter of Section 36, Township 3 North, Range 7 East of the Willamette Meridian in the County of Skamania, State of Washington described as follows:

Commencing at a point on the South side of Loop Road (Wills Hot Springs Alameda) said point being North 0 degrees 4 minutes East 1081.3 feet from the quarter corner on the South Line of Section 36; thence North 62 degrees 4 minutes West 150.7 feet along the South Line of the County Road; thence South 14 degrees 19 minutes West 173.8 feet; thence South 89 degrees 41 minutes East 176 feet to the centerline of said Section 36; thence North 0 degrees 4 minutes East along said Line 100 feet to the Point of beginning.
