Containing 0.36 acres, more or less

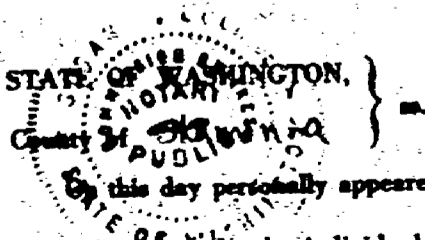
