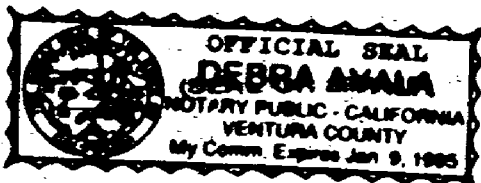

EXHIBIT "A"

A Tract of land in the South half of the Southwest quarter of Section 22, Township 2 North, Range 6 East of the Willamette Meridian, in the County of Skamania, State of Washington described as follows:

Beginning at a point on the South Line of the said South half of the Southwest quarter North 89 degrees 21' 31" West 125.00 feet from the Southeast corner of the Southwest quarter of the Southwest quarter of said Section 22; thence North 01 degrees 11' 07" East parallel with the East line of said Southwest Quarter of the Southwest quarter 450.01 feet; thence South 89 degrees 21' 31" East parallel with the South line of said South half of the Southwest quarter 468.68 feet to the center line of County Road No. 1014 designated as the Woodard Creek Road; thence following said center line along the arc off a 1,226.20 foot radius curve to the left (the incoming tangent of which is South 16 degrees 18' 08" West) for an arc distance of 102.77 feet; thence leaving said center line (at a point 350 feet North 01 degrees 11' 07" East of the South line of the said Section 22) North 89 degrees 21' 31" West parallel with said South line 321.07 feet to the East line of the Southwest quarter of the Southwest quarter; thence South 01 degrees 11' 07" West along said East line 350 feet to the North 89 degrees 21' 31" West along the South line of said Section 22, 125.00 feet to the point of beginning.
