Grantor conveys to Trustee for benefit of Lenders as Beneficiary, with power of sale, all of Grantor's right, title, and interest in and to the following described real property (the "Real Property"), together with all existing or subsequently crected or affixed improvements or fixtures located in SKAMANIA County, State of Washington

SEE ATTACHED SCHEDULE "A"

Grantor presently assigns to Lender (also known as Beneficiary) all of Grantor's right, title, and interest in and to all rents, revenues, income, issues, and profits (the "Income") from the Real Property described above.

Grantor grants Lender a Uniform Commercial Code security interest in the Income and in all equipment, fixtures, furnishings, and other articles of personal property owned by Grantor, now or subsequently attached or affixed to the Real Property described above, together with all accessions, parts, or additions to, all replacements of, and all substitutions for any of such property, and together with all proceeds (including insurance proceed; and refund of premism) from any sale or other disposition (the "Personal Property"). The Real Property and the Personal Property are collectively referred to as the "Property".

Grantor has agreed to provide the Property as collateral to secure an obligation of ICC Grantor

("Obligor") in the principal amount of \$48,500.00.

This amount is repayable with interest according to the terms of a promissory note or other credit agreement given to evidence such indebtodates dated August 24, 1994.

The term "Credit Agreement" as used in this Deed of Trust means the promisery note or other Credit Agreement describing the repayment terms of the Indebtedness, and any notes, agreements, or documents given in renewal, modification, extension or substitution for the promissory note or Credit Agreement originally issued. The rate of interest on the Credit Agreement is subject to indexing, adjustment, renewal, or renegotiation.

The term "Indebtedness" as used in this Deed of Trust means all principal and interest payable under the Credit Agreement plus (a) any amounts expended or advanced by Lender to discharge obligations of Granter and (b) any expenses incurred by the Lender or Trustee to enforce obligations of Granter horsunder, as permitted under this Deed of Trust, together with interest thereon at the Credit Agreement rate.

The term 'Grantor' is used in this Deed of Trust for convenience of the parties, and use of that term shall not affect the linbility of any such Grantor on the Credit Agreement. Any Grantor who co-signs this Deed of Trust, but does not execute the Credit Agreement: (a) is co-signing this Deed of Trust only to grant and convey that Grantor's interest in the Property to Trustée under the terms of this Deed of Trust, (b) is not personally liable under the Credit Agreement except us etherwise provided by law or contract, (c) agrees that the Lender and any other Grantor hereundis; may agree to extend, modify, ferobear, release any collateral, or make any other accommodations or amendments with regard to the terms of this Deed of Trust or the Credit Agreement, without notice to that Grantor, without that Grantor's consent, and without releasing that Grantor or modifying this Deed of Trust as to that Grantor's interest in the Property; and (d) acknowledges that Lender would not have entered into the lending relationship relating to the Indebtodness except for reliance upon all of the obligations of all the Borrowers under this Deed of Trust.

This Deed of Trust, including the assignment of Income and the security interest, is given to secure payment of the Indebtedness and performance of all obligations under the Credit Agreement and all obligations of Grantor under this Deed of Trust and is given and accepted on the following

Payment and Performance.

Grantor shall pay to Lender all amounts secured by this Deed of Trust as they become due, and shall strictly perform all of Grantor's obligations.

Possession and Maintenance of the Property.

2.1 Possession. Until in default, Borrower may remain in possession and control and operate and manage the Property and collect the Income from the Property.

Duty to Maintain. Grantor shall maintain the Property in first class condition and promptly perform all

repairs and maintenance necessary to preserve its value.

2.3 Nuisance, Waste. Grantor shall neither conduct or permit any nuisance nor commit or suffer any strip or waste on or to the Property or any portion thereof including without limitation removal or alienation by Grantor of the right to remove any timber, materials (including oil and gas), or gravel or rock products.

2.4 Removal of Improvements. Grantor shall not demolish or remove any improvements from the Real Property without the prior written consent of Lender. Lender shall consent if Grantor makes arrangements satisfactory to Lender to replace any improvement which Grantor proposes to remove with one of at least equal value. "Improvements" shall include all existing and future buildings, structures, and parking facilities.

2.5 Lender's Right to Bater. Lender and its agents and representatives may enter upon the Property at all reasonable times to attend to Lender's interest and inspect the Property.

Compliance With Governmental Requirements. Grantor shall promptly comply with all laws, ordinances, and regulations of all governmental authorities applicable to the use or occupancy of the Property. Grantor may contest in good faith any such lew, ordinance, or regulation and withhold compliance during any proceeding, including appropriate appeals, so long as Grantor has notified Lender in writing prior to doing so and Lender's interest in the Property is not jeopardized. Lender may require Grantor to post adequate security (reasonably satisfactory to Lender) to protect Lender's interest.

2.7 Duty to Protect. Grantor shall do all other acts, in addition to those set forth in this section, that from the character and the use of the Property are reasonably necessary to protect and preserve the security.

Construction Loan. If some or all of the proceeds of the loan creating the Indebtedness is to be used to construct or complete construction of any Improvements on the Property, the Improvements shall be completed within six (6) months from the date of this Deed of Trust or such other time period as may be set by the Lender and Grantor shall pay in full all costs and expenses in connection with the work. Lender, at its option, may dishurse lean proceeds under such terms and conditions as Leader may deem necessary to insure that the lien of this Deed of Trust shall have priority over all possible other liens, including those of material suppliers and workmen. Lender may require, among other things, that disberrement requests be supported by receipted bills, expense affidavits, waivers of liens, construction progress reports, and such other documentation as Lender may

3. Taxes and Liens.

3.1 Payment. Grantor thall pay when due before they become delinquent all taxes and assessments levied against or on account of the Property, and shall pay when due all claims for work done on or for services rendered or material furnished to the Property. Grantor shall maintain the Property free of any liens having priority over or equal to the interest of Lender under this Doed of Trust, except for the lien of taxes and assessments not

due, except for the prior indebtedness referred to in Section 17, and except as otherwise provided in Subsection 32. Right to Contest. Grantor may withhold payment of any tax, assessment, or claim in connection with a good faith dispute ever the obligation to pay, so long as Lender's interest in the Property is not jeopardized. If a lien arises or is filed as a result of acompayment, Granter shall within 15 days after the lien arises or, if a lien is filed, within 15 days after Grantor has notice of the filing, secure the discharge of the lien or deposit with Lender, cash or a sufficient corporate serety bond or other security satisfactory to Lender in an amount sufficient to discharge the lien plus any costs, attorneys' fees, or other charges that could accrue as a result of a foreclosure or sale under the lien.

3.4 Notice of Construction. Granter shall notify Lender at least 15 days before any work is commenced, any e furnished, or any materials are supplied to the Property if a countraction lien could be asserted on account of the work, services, or materials and the cost exceeds \$5,000.00 (if the Property is used for nonresidential or commercial purposes or \$1,000.00 if the Property is used as a residence). Grantor will on request furnish to Lender advance assurances satisfactory to Lender that Grantor can and will pay the cost of such 4.1 Maintenance of Insurance. Grantor shall procure and maintain policies of fire insurance with standard extended coverage endorsements on a replacement basis for the full insurable value basis covering all Improvements on the Real Property in an amount sufficient to avoid application of any coinsurance clause, and with a mortgagee's loss payable clause in favor of Lender. Policies shall be written by such insurance companies and in such form as may be reasonably acceptable to Lender. Grantor shall deliver to Lender certificates of coverage from each insurer containing a stipulation that coverage will not be cancelled or diminished without a minimum of 10 days' written notice to Lender.

4.2 Grantor's Report on Insurance. If the Property is not used as Grantor's residence within 60 days after the close of its fiscal year, Grantor shall furnish to Lender a report on each existing policy

of insurance showing:

(a) the name of the insurer,

(b) the risks insured,

(c) the amount of the policy,

(d) the Property insured, the then current replacement value of the Property and the manner of determining that value, and

(e) the expiration date of the policy.

Grantor shall, upon request, have an independent appraiser satisfactory to Lender determine the cash

value replacement cost of the Property.

4.3 Application of Proceeds. Grantor shall promptly notify Lender of any loss or damage to the Property. Lender may make proof of loss if Grantor fails to do so within 15 days of the casualty. Lender may, at its election, apply the proceeds to the reduction of the Indebtedness or the restoration and repair of the Property. If Lender elects to apply the proceeds to restoration and repair, Grantor shall repair or replace the damaged or destroyed Improvements in a manner satisfactory to Lender Lender shall, apon satisfactory proof of such expenditure, pay or reimburse Grantor from the proceeds for the reasonable costs of repair or restoration if Grantor is not in default hereunder. Any proceeds which have not been paid out within 180 days after their receipt and which Lender has not committed to the repair or restoration of the Property shall be used to prepay first accrued interest and then principal of the Indebtedness. If Lender holds any proceeds after payment in full of the Indebtedness, such proceeds shall be paid to Grantor.

4.4 Unexpired Insurance at Sale. Any unexpired insurance shall inure to the benefit of, and pass to, the purchaser of the Property covered by, this Deed of Trust at any trustee's or other sale held under the

provision contained within, or at any foreclosure sale of such Property.

4.5 Compliance, with Prior Indebtedness. During the period in which any prior Indebtedness described in Section 17.1 is in effect, compliance with the insurance provisions contained in the instrument evidencing such prior Indebtedness shall constitute compliance with the insurance provisions under this Doed of Trust, to the extent compliance with the terms of this Deed of Trust would constitute a duplication of instrance requirement. If any proceeds from the insurance become payable on loss, the provisions in this Deed of Trust for division of proceeds shall apply only to that portion of the proceeds not payable to said holder of the prior Indebtedness.

4.6 Association of Unit Owners. In the event the Real Property has been submitted to unit ownership pursuant to a Unit Ownership Law, or similar law for the establishment of condominiums or cooperative ownership of Real Property, the insurance may be carried by the association of anit owners in Grantor's behalf, and the proceeds of such insurance may be paid to the association of unit owners for the purpose of repairing or reconstructing the Property. If not so used by the association, such proceeds

shall be paid to Lender.

4.7 Insurance Reserves. Subject to any limitations set by applicable law, Lender may require Grantor to maintain with Lender reserves for payment of insurance premiums, which reserves shall be created by monthly payments of a sen: estimated by Lender to be sufficient to produce, at least 15 days before due, amounts at least equal to the insurance premiums to be paid. If it days before payment is due the reserve funds are insufficient, Grantor shall spon demand pay any deficiency to Lender. The reserve funds shall be held by Lender as a general deposit from Grantor and shall constitute a nominterestbearing debt from Lender to Grantor, which I fy (required to be paid by Grantor as they become due. (g) If the interest of Grantor in the Property is a lesschold interest, any default by Grantor under the terms of the lease, or any other Event (whether or not the fault of the Grantor) that results in the termination of Grantor's leasehold rights.

(h) Any breach by Grantor under the terms of any other agreement between Grantor and Lender that is not remedical within any grace period provided therein, including without limitation any agreement concerning any indebtedness of Grantor to Lender, whether made now or later.

14. Rights and Remedies on Default.

14.1 Remedies. Upon the occurrence of any event of default and at any time thereafter, Trustee or Lender may exercise any one or more of the following rights and remedies, in addition to any other rights or remedies, provided by law:

(a) Lender shall have the right at its option without notice to Grantor to declare the entire Indebtedness immediately due and payable, including any prepayment penalty which Grantor would be required to

(b) With respect to all or any part of the Real Property, the Trustee shall have the right to foreclose by notice and sale, and Lender shall have the right to foreciose by judicial foreclosure, in either case in accordance with and to the full extent provided by applicable law

(c) With respect to all or any part of the Personal Property, Lender shall have all the rights and remedies of a secured party under the Uniform Commercial Code in effect in the state in which the Londor is located.

(d) Lender shall have the right, without notice to Granter, to take possession of the Property and collect the Income, including amounts past due and unpaid, and apply the net proceeds, over and above Lender's costs, against the Indebtoduces. In furtherance of this right, Lender may require any lemant or other user to s is collected by Lender, then Granter irrevocably designates Lander as Granter's attorney in fact to endorse instruments received in payment thereof in the name of Granter and to negotiate the same and collect the proceeds. Payments by tenants or other users to Lender in response to Lender's demand shall satisfy the obligation for which the payments are made, whether or not any proper grounds for the demand existed. Lender may exercise its rights under this subparagraph either in person, by agent, or through a receiver.

(c) Lender shall have the right to have a receiver appointed to take personion of any or all of the Property, with the power to protect and preserve the Property, to operate the Property preceding foreclosure or mic, and to collect the Income from the Property and apply the proceeds, over and above cost of the receivership, against the Indebtedness. The receiver may surve without bend if permitted by lev. Londor's right to the appointment of a receiver shall exist whether or not the apparent value of the Property exceeds the Indebtodness by a substantial amount. Employment by

Lander shall not disqualify a person from serving as a receiver.

(f) If Grantor remains in possession of the Property after the Property is sold as provided above or Lender otherwise becomes entitlee to possession of the Property upon default of Grantor, Grantor shall become a tenant at will of Lender or the purchaser of the Property and shall pay while in possession a reasonable rental for use of the Property.

(g) If the Real Property is submitted to unit ownership, Lender or its designee may vote on any matter that may come before the members of the association of unit owners, pursuant to the power

of attorney granted Lender in Section 16.2.

(h) Trustee and Lender shall have any other right or remedy provided in this Deed of Trust, or the Note.

14.2 Sale of the Property. In exercising its rights and remedies, the Trustee or Lender shall be free to sell all or any part of the Property together or separately, in one sale or by separate sales. Lender shall be entitled to bid at any public sale on all or any portion of the Property.

14.3 Notice of Sale. Lender shall give Grantor reasonable notice of the time and place of any public sale of the Personal Property or of the time after which any private sale or other intended disposition of the Personal Property is to be made. Reasonable notice shall mean notice given

at least ten days before the time of the sale or disposition.

- 14.4 Waiver, Blection of Remedies. A waiver by any party of a breach of a provision of this Deed of Trast shall not constitute a waiver of or prejudice the party's rights otherwise to demand strict compliance with that provision or any other provision. Election by Lender to pursue any remedy shall not exclude pursuit of any other remedy, and an election to make expenditures or take action to perform an obligation of Grantor under this Deed of Trust after failure of Grantor to perform shall not affect Lender's right to declare a default and exercise its remedies under this Deed of Trust.
- 14.5 Attorney's Fees; Expenses. If Lender institutes any suit or action to enforce any of the terms of this Deed of Trust, Lender shall be entitled to recover such sum as the court may adjudge reasonable as attorneys' fees at trial and on any appeal. Whether or not any court action is involved, all reasonable expenses incurred by Lender that in Lender's opinion are necessary at any time for the protection of its interest or the enforcement of its rights shall become a part of the Indebtedness payable on demand and shall bear interest from the date of expenditure until repaid at the rate of 12 percent per annum or at the rate of the Note, whichever is higher. Expenses covered by this paragraph include (without limitation) all attorney fees incurred by Lender whether or not there is a lawsuit, the cost of searching records, obtaining title reports (including foreclosure reports), surveyors' reports, appraisal fees, title insurance, and fees for the Trustee, to the extent permitted by applicable law.

15. Notice.

Any notice under this Deed of Trust shall be in writing and shall be effective when actually delivered or, if mailed, shall be deemed effective on the second day after being deposited as registered or certified mail, postage prepaid, directed to the address stated in this Deed of Trust. Any purty may change its address for notices by written notice to the other parties. Lender requests that copies of notices of foreclosure from the holder of any lien which has priority over this Deed of Trust be sent to Lender's address, as set forth on page one of this Deed of Trust.

16. Miscellaneeus.

Successors and Assigns. Subject to limitations stated in this Deed of Trust on transfer of Granter's interest, and subject to provisions of applicable law with respect to successor trustees, this Doed of Trust shall be binding upon and inure to the benefit of the parties, their successors and assigns.
