## EXHIBIT "A"

Beginning at the Southeast Corner of the North Half of the South Half of the Northeast Quarter of the Southeast Quarter of Section 34, Township 2 North, Range 5 East of the Willamette Meridian, in Skamania County, Washington; thence North 89 degrees 29' 03" West along the South line of said North Half of the South Half of the Northeast Quarter of the Southeast Quarter of said Section 34, 261.82 feet to the True Point of Beginning; thence continuing North 89 degrees 29' 03" West 479.85 feet; thence North 01 degrees 11' 36" East parallel with the East line of the Southeast Quarter of said Section 34, 328 feet, more or less, to the centerline of Mabee Mines County Road; thence Easterly along said road to a point which bears North 01 degrees 11' 36" East from the True Point of Beginning; thence South 01 degrees 11' 36" West parallel to the East line of said Southeast Quarter of Section 34, 472 feet, more or less, to the True Point of Beginning.
