EXHIBIT "A"

That portion of the East half of the Northeast quarter of the Southwest quarter of Section 21, Township 3 North, Range 10 East of the Willamette Meridian, in the County of Skamania, State of Washington, described as follows:

BEGINNING at a point on the Southerly line of the County Road known and designated as the Underwood-Willard Highway, said point being 1801.1 feet South and 179.7 feet East of a railroad iron marking the Southwest corner of the East half of the Northeast quarter of the Northwest quarter of the said Sections 21; thence South 839 feet, more or less, to the South line of the Northeast quarter of the Southwest quarter of the said Section 21; thence West along said South line 180 feet, more or less, to the Southwest quarter of the East half of the Northeast following the West line of the East half of the Northeast quarter of the Southwest quarter of the said Section 21; thence the Southwest quarter of the Bast half of the Northeast quarter of less, to intersection with the Southerly line of the Underwood-Willard line of said highway 192.4 feet, more or less, to the Point of Beginning.
