Attachment "A" STATEMENT

On the morning of August 29, 1994, I took my pager off of the driver's sun visor in my van and put it into my purse. I came into my office at approximately 7:45 a.m. (room 25 in the courthouse). When I left my vehicle, I zipped my purse closed and brought it into my office and set it next to my typewriter. I opened my purse and took my pager and either my wallet or appointment calendar (I cannot remember for sure which) and set both on the counter (window ledge) above my purse. During the day sometime, I had put the wallet/calendar back into my purse. This pager has been assigned to me and is the property of Klickitat County Fire District No. 4 of Lyle, Washington.

I had planned on taking annual leave at 12:30 p.m. on August 29th; however, I did not actually leave until approximately 1:35 p.m. I closed my purse and went to my car and left. As I was driving east on Vancouver Avenue (between the county annex and the Fort Vancouver Regional Library), I remembered that I had left my pager in my office. When I stopped at the stop sign at the bottom of the hill (on the east side of the Stevenson Arco station), I checked my purse for the pager and it was not in my purse. I decided, since my office is not open to the public and I was already going to be late for my appointment, that I would just get my pager in the morning when I arrived and put it back into my purse.

On August 30th (the first day of school), I arrived in my office (after taking my children to school) at approximately 10:20 a.m. My pager was no where to be seen. On Wednesday morning (August 31), I called Undersheriff Grossie and inquired as to whether or not there had been a pager turned in as having been "lost" or "found" and was told no. I proceeded to explain to him at that point what had happened.

I have searched everywhere possible (in the office and outside) and there has been absolutely no evidence of it anywhere. Also, just for information, when my pager was "on" and in my office, the static electricity in the air would cause it to "key" or make "scratchy" noises occasionally. None of these sounds were heard anywhere within the first two weeks the pager was missing (approximate time for the battery to totally loose it's charge).

I have to assume the pager was stolen from the window ledge in my office. I believe my co-worker also left earlier than her usual time on August 29th. If this is so, then the office would have had the lights off in the south portion of the office, with the door to the hallway propped open and the light immediately inside on so others could use the copy machine.

I filed a report of theft with the Skamania County Sheriff approximately one week after the disappearance. I submitted the information to Undersheriff Grossie. Later I was told that the matter had been assigned to Deputy Converse. I had a color brochure of pagers (from the manufacturer) which showed my model of pager and I sent this over to the Sheriff's office for their information. I have not had any contact from Deputy Converse; a copy of his report is attached to this statement. I notified the Skamania County Pioneer of the pager disappearance and they have run lost and found ads (free of charge) for the last four weeks (a copy is also attached of the ad).

I called the manufacturer and requested a written quote on the replacement cost for the pager, without a charger. I found that the model is no longer made; however, an equivalent model replaces the model I had. The original purchase cost of my pager, with a charger, was approximately \$289 without Washington State sales tax. I have attached a copy of the fax which I received today from the manufacturer.
