THIS AGREEMENT, Made and entered into this 18th day of October, 1994, by and between Victor O. Erickson, Larry G. Erickson hereinafter called the Seller, residing in the City of Washougal, State of WA, and Ronald L. Lorraine, A. Huff hereinafter called the Purchaser, residing in the City of Washougal, State of WA.

WITNESSETH, That the Seller agrees to sell and the Purchaser agrees to purchase the following described real estate, with the appurtenances thereon, to wit:

Lot 2 of shor plat book 2 page 91 recorded in Skamania County. Recorded under recording number 88116 lying within north 1/2 of Section 28 township 2 North, Range 5 East of Willamette Meridian

situated in Skamania County, State of WA, on the following terms: the total purchase price is Thirty-six Thousand Dollars (\$36,000.00) of which the sum of Seven Thousand Two Hundred Dollars (\$7,200.00) has this day been paid by Purchaser, the receipt whereof is hereby acknowledged by Seller, and the balance of Twenty-Eight Thousand Eight Hundred Dollars (\$28,800.00) to be paid in the amounts and at the times stated as follows:

monthly payments in the amount of \$360.00. To be paid by the 5th of each month, beginning with November 5th 1994.

with interest on all deferred payments to be computed from the date of this agreement at the rate of 8 1/2 per cent per annum and to be paid on each principal payment date. Purchaser may make larger payments at anytime, or pay the contract in full, and interest shall immediately cease on all payments so made.

It is agreed that the Purchaser shall have possession of said premises from the 18th day of October, 1994, provided that all the terms and conditions of this agreement are fully complied with.

Purchaser agrees to pay all taxes and assessments legally levied against said property subsequent to this date, before the same shall become delinquent. Purchaser agrees to keep and maintain insurance on the improvements on said premises in the sum of not less than \$10,000.00 Dollars (\$_____).

Purchaser also agrees to assume all hazards of damage to or destruction of any improvements on said premises, and agrees to keep the buildings and all improvements on the premises in good condition and repair and not to permit waste; and agrees not to use the premises for any illegal purpose.

In the event that the Purchaser shall fail to make any payment herein provided, the Seller may pay such taxes or assessments and effect such insurance, and any amount so paid by the Seller shall be deemed a part of the purchase price and shall become payable forthwith, with interest at the rate of 8 1/2 per cent per annum until paid, without prejudice to any other rights of Seller by reason of such failure.

The Purchaser agrees that a full inspection of the premises has been made and that neither the Seller nor assigns shall be liable under any covenants respecting the condition of the premises or for any agreement for alterations, improvements or repairs unless the covenant or agreement relied upon is in writing and is attached to and made a part hereof.

The Seller agrees to procure within ten days of the date hereof, a Purchaser's policy of title insurance, insuring the Purchaser to the full amount of the purchase price against loss and damage by reason of defect in the title of the Seller to the real estate herein described or of reason of prior liens not assumed by the Purchaser in this agreement.

The Seller agrees, on full payment of the purchase price and interest in the manner hereinbefore specified, to execute and deliver to Purchaser a Warranty Deed to the real estate, excepting any part which may hereafter be condemned, free and clear of encumbrances, except those mentioned herein and any that may accrue hereafter through any person other than the Seller.

Time is of the essence of this agreement. If the Purchaser shall fail to comply with or perform any covenant or agreement hereof promptly at the time and in the manner herein required, the Seller may elect to declare a forfeiture by written and recorded notice to the Purchaser, and at the expiration of 90 days thereafter this agreement shall be at an end and null and void if in the meantime the terms of the agreement have not been complied with by Purchaser. In such event and upon Seller doing so, and upon compliance with the provisions of R.C.W. 61.30, all payments made by the Purchaser hereunder and all improvements placed upon the premises shall be forfeited to the Seller as liquidated damages, and the Seller shall have the right to re-enter and take possession. Service of all demands and notices with respect to such declaration of forfeiture and cancellation may be made by registered mail at the following address: Mr. O. L. Ambrose Rd or at such other address as the Purchaser shall indicate to the Seller.

or Seller's agent or attorneys in writing or which is known to the one giving notice. In the event of the taking of any part of the property for public use, or of the destruction of any of the improvements on the property by fire or other casualty, the moneys received by reason thereof shall be applied as payment on account of the purchase price of the property, less any sum which may be required to be expended in procuring such money, or to the rebuilding or restoration of the premises.

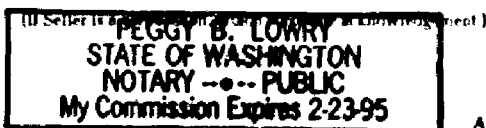
