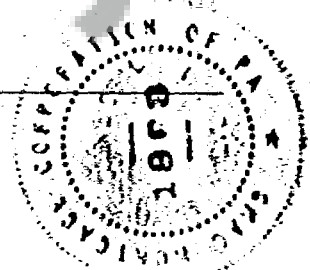

EXHIBIT "A"

A portion of the South half of the Northwest quarter of Section 19, Township 2 North, Range 5 East of the Willamette Meridian, in the County of Skamania, State of Washington, described as follows:

Beginning at the Southeast corner of the Northwest quarter of the said Section 19; thence West along the South line of the Northwest quarter of the said Section 19, 1,670 feet to the True Point of Beginning; thence North parallel to the East line of the Northwest quarter of said Section 19, a distance of 395 feet; thence West parallel to the South line to the Northwest quarter of said Section 19, 330 feet, more or less, to the Northeast corner of the real estate conveyed to David C.
