 together with all after acquired title of the grantor(s) therein:

A portion of the North half of the Northwest quarter of Section 19, Township 1 North, range 5 East of the Willamette Meridian, more particularly described as follows:

Beginning at a point on the section line 56 rods South of the Northwest corner thereof; thence East to the quarter section line; thence South to the South line of the North half of the Northwest quarter; thence West to the section line; thence North to the point of beginning;

And also a 25 foot square tract surrounding a spring located approximately 980 feet East and 180 feet South of the Northwest corner of said Section 19, together with an easement to install and maintain a water pipeline from the aforesaid spring to the property first above described, which pipeline shall be not less than 18 inches below the surface of the ground;
