All policies shall be held by the Beneficiary, and be in such companies as the Beneficiary may approve and have loss payable first to the Beneficiary, as its interest may appear, and then to the Grantor. The amount collected under any insurance policy may be applied up in any indebte disess hereby secured in such order as the Beneficiary shall determine. Such application by the Beneficiary shall not cause discontinuance of any proceedings to foreclose this Deed of Trust. In the cost of freeclosure, all rights of the Grantor in insurance policies then in force shall pass to the purchaser at the forcelosure sale
- 4. To defend any action or proceeding purporting to affect the security hereofor the rights or powers of Beneficiary or Trustee, and to pay all costs and expenses, including cost of fifte search and attorney's fees in a reasonable amount, in any such action or proceeding, and in any suit brought by Heneficiary to forcel so this Deed of Trust.

By accepting payment of any sum secured hereby after its due date, Beneficiary does not waive its right to require prompt payment when due of all other sums so secured or to declare default for failure to so pay, 3.
