PROVISIONS

"The instantaneous amount of water granted under this water right is a maximum limit that shall not be exceeded. Water availability under this authorization is subject to natural fluctuations and may not provide a continual year-round supply."

At such time that the Department of Ecology determines the regulation and management of the subject waters is necessary and in the public interest, an approved measuring device shall be installed and maintained in accordance with RCW 90.03.360 and WAC 508-64-020 through -040.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described, except as provided in RCW 90.03.380, 90.03.390, and 90.44.020.

This certificate of water right is specifically subject to relinquishment for nonuse of water as provided in RCW 90.14.180.

PARCEL B:

That portion of the E. C. Hardy Donation Land Claim No. 41, situated in Section, T. 2 N., R. 7 E.W.M., and of E. C. Hardy D.L.C. No. 38, situated in Section 25, T. 2 N., R. 6 E.W.M., described as follows:

Beginning at the intersection of the west line of the S.M. Hamilton Donation Land Claim No. 40 and the north line of said Section 30; thence west along said section line to the intersection with the southerly right-of-way line of the Spokane, Portland & Seattle Railway Company; thence southwesterly along said right-of-way to the west line of the said E.C. A tract of land situated in E.C. Hardy D.L.C. No. 41 in the northeast quarter of Section 30, T. 2 N., R. 7 E.W.M., Skamania County, Washington, being more particularly described as follows:

Beginning at the northeast corner of the E.C. Hardy Donation Land Claim No. 41; thence south 89°31'02" west along the north line of said D.L.C., 1,643.07 feet; thence south 29°58'55" west, 119.59 feet; thence south 18°27'10" east 1,452.91 feet; thence south 67°00'00" east to the ordinary highwater meander line of Hamilton Slough; thence northeasterly along said meander line to the east line of the said E.C.
