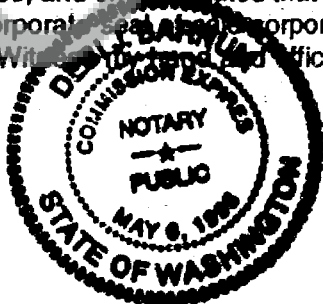

A tract of land in the Southeast quarter of the Northeast quarter of Section 20, Township 2 North, Range 5 East of the Willamette Meridian, in the County of Skamania, State of Washington described as follows:

BEGINNING at the Southeast corner of the Northeast quarter of Section 20, Township 2 North, Range 5 East of the Willamette Meridian; thence North $01^{\circ} 23' 49''$ East along the East line of said Northeast quarter, 268.31 feet; thence North $88^{\circ} 12' 57''$ West parallel to the South line of the North half of the Northeast quarter of the Northeast quarter, 704.59 feet to the center of a private road, more particularly described on Short Plat approval recorded at Page 43 to 43J of Book 1 of Short Plats, under Auditor's File No. 82512, records of Skamania County, Washington; thence Southerly along said road easement to the South line of said Northeast quarter of Section 20; thence South $88^{\circ} 35' 38''$ East 655.37 feet to the Point of Beginning.
