1. The nonexempt earnings of defendant that have accrued through the last payroll period ending on or before sixty (60) days after the date you received the writ of garnishment and accompanying first answer forms (gross earnings) 1,833.00
2. **LESS:** Deductions: \*Monthly\*
  - Social Security 59.33
  - Withholding taxes 140.22
  - Any other deduction required by law (list & identify) PERS 91.65
3. **EQUALS:** Disposable earnings WA ST SUPPORT \$ 150.00
4. **LESS:** The **GREATER** of: Dues/Ins 48.36
  - a. Seventy-five percent (75%) of the disposable earnings as figured above; 1,343.44
  - OR**
  - b. \$127.50 for each week of compensation due under this writ. (If amounts are due for more than one week, multiply the number of weeks due by \$127.50. If the amounts due are for portions of a week, you must calculate the fraction or fractions of the week and multiply by \$127.50. 510.00
5. **EQUALS:** The amount the garnishee holds for the second answer \$ 510.00
6. **PLUS:** The amount garnishee held under first answer + 255.00
7. **EQUALS:** THE TOTAL AMOUNT HELD BY GARNISHEE UNDER THE FIRST & SECOND ANSWERS (No. 5 + No. 6) \$ 765.00

The amount you enter in item #4 is the exempt amount and must be paid to the defendant at the regular pay time. List all of the personal property or effects of defendant in the garnishee's possession or control when the writ was served. (Use the reverse side of this answer form or attach a schedule if necessary.)
