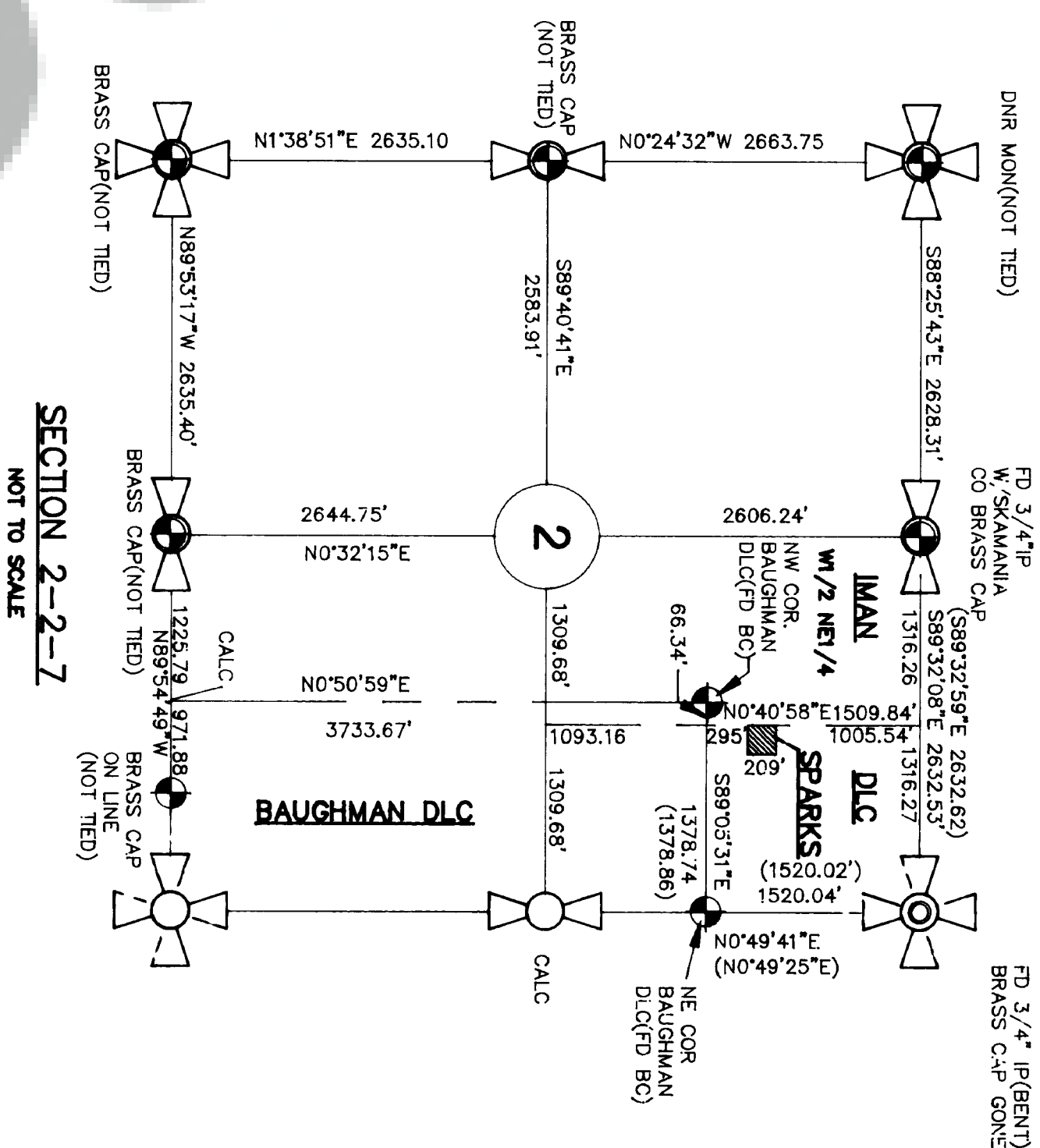

EXISTS ON THE GROUND.**

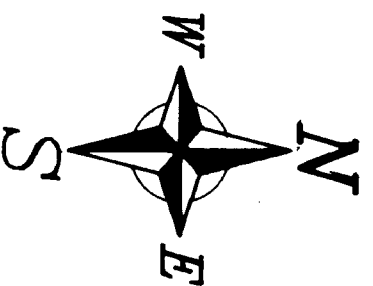

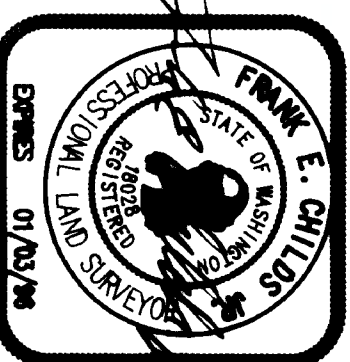
